Turn right on Bloserville Rd, follow approx 3 miles. Cross over Enoia Rd, PA 944, remain on Bloserville Rd ½ mile. Turn left on Lonesome Rd. Training Facility is on left hand side of road and is marked with a Dandy Dog Training Sign. Approximately 10 miles from Carlisle, PA

These trials will be held inside under a roof, with climate control. There is crating space available inside the building in a separate area. Please bring a tarp to place under a crate to help protect the training room floors.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and run at the end of their class/trial. This may require a bitch in season to be crated outside within a vehicle. Entry fees for bitches that come into season will be refunded if you wish to withdraw. If bringing a bitch in season, please inform the trial committee prior to the trial and all exhibitors at the judge’s briefing.

Liability Waiver
