Turn right on Bloserville Rd, follow approx 3 miles. Cross over Enoia Rd, PA 944, remain on Bloserville Rd ½ mile. Turn left on Lonesome Rd.

RUNNING ORDER: Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. Every reasonable effort will be made to accommodate those dogs with event conflicts, however, the handler does have responsibility

Friday night, 5:00 Masters and Crazy 8s(two Trials) in both Ring 1 and 2.

Limited to 25 master runs per trial

Saturday and Sunday, Ring 1:
Instinct (offered once) begins at 9 AM,
followed by Novice, Trial 1 and 2,
then Open Trial 1 and 2

Ring 2 will not begin before 9:30 AM with
Seniors and Masters. 1 Crazy Eights trial to
follow each day.

Saturday and Sunday are limited to 100 runs (not
including Crazy 8s)

These trials will be held inside under a roof, with climate control. There is crating space available inside the building in a separate area. Please bring a tarp to place under a crate to help protect the training room floors.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and run at the end of their class/trial. This may require a bitch in season to be crated outside within a vehicle. Entry fees for bitches that come into season will be refunded if you wish to withdraw. If bringing a bitch in season, please inform the trial committee prior to the trial and all exhibitors at the judge's briefing.

Liability Waiver

I (we) acknowledge that if this application for the entry of this dog is made available to me (us) for participation in a Barn Hunt event, that I (we) agree that this facility has the right to refuse the entry of this dog and/or they reserve the right to dismiss the dog and myself for cause which Barn Hunt deems to be sufficient. In consideration of the acceptance of this and the opportunity to train my dog(s), I (we) agree to hold Barn Hunt Association, LLC, TNT Canines, COBRA and all associates harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog or dogs while in or upon the premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for damage or injury to the dog or myself, either physically or mentally, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by negligence while in or upon the premises of the Barn Hunt grounds. The terms of this agreement bind the parties for the current period of training, and all subsequent classes/training/events in which they hereafter participate.
