From Rt 81 near Carlisle, take exit 44 for PA 465 N to Plainfield. Turn on Allen Rd/PA 465 (signs for US 11/Plainfield, PA 465 N) Turn left at Newville Rd/PA 641, 5.2 miles.

Turn right on Bloserve Rd, follow approx 3 miles. Cross over Enoia Rd, PA 944, remain on Bloserve Rd ½ mile. Turn left on Lonesome Rd. Training Facility is on left hand side of road and is marked with a Dandy Dog Training Sign. Approximately 10 miles from Carlisle, PA.
